Business meeting held on Tuesday, February 12, 2019. Chairman Dennis Knowlton called the meeting to order at 7:00 pm. Motion to approve the minutes by Mr. Knowlton, second by Mr. Searle. Road Master, Kurt Booths, reported that Barhite Excavating will now include Hemlock and Sugar Maple Lane in snow removal instead of drafting a snow removal agreement with Fell Township.
