Business meeting held on Tuesday, March 13, 2018. Chairman Dennis Knowlton called the meeting to order at 7:05 pm. Motion to approve the minutes by Mr. Searle, second by Mr. Knowlton. All in favor. Treasurer's report reviewed and will be put on file. List of bills reviewed. Mr. Knowlton made a motion to pay bills, except for Clifford Auto, Clifford Supply or the Innanen lease reimbursement to Mr. Knowlton, second by Mr. Searle. All in favor. Mr. Knowlton made a motion to pay Clifford Auto and Clifford Supply, second by Mr. Searle. All in favor. Mr. Marcho abstained due to potential conflict of interest. Old Business: Mr. Searle addressed how tax money is being allocated and what the supervisors are doing to "sell" the township as a viable business location to potential investors. Mr. Searle commented on suggestions made by a resident to bring in businesses and the idea of a farmer's market was brought up again. Mr. Searle said if there is interest in moving forward with this idea there is paperwork already started.

Township resident, Mr. Pettinato, made a suggestion of getting the county or state involved is building a senior living center in the township. Mr. Searle said he would look into the idea.

EMC, Mr. Price, commented on the progress of the townships Hazard Mitigation Plan. He also informed that there is a burn ban in effect from March 15th to April 13th. Mr. Searle asked if Mr. Price, Mr. Marcho and Mr. Wilson could look into having a generator, sump pump and blankets for the township building to have on hand in case of an emergency. All in favor.

New Business: Spring Road bids from Brozonis Excavating and Barhite Excavating were opened. It appears Barhite Excavating is the winner, pending approval from Atty. McGraw and Ed Sumski, from PennDot. All in favor.

She also recommended rescinding ordinances' and or removing them from the township website that no longer pertain to the town or are not enforced.
