Business meeting held on Tuesday, May 10, 2022 at the Clifford Township Municipal building. Vice-Chairman Searle called the meeting to order at 7:00pm. Mr. Searle opened the floor for public comment. New Business: Fish Commission Assistance Request-Motion by Mr. Searle to fill out a request and allow fish commission permission to give Township an evaluation and recommendations for improving trout fishing, 2<sup>nd</sup> by Mr. Marcho. PSATS Annual Conference- Mr. Searle attended the annual conference and brought back brochures for helping the Township prepare for disasters especially for older residents and residents with disabilities and updated the Township on current events such as releasing permits prior to disaster cleanups, minimum certification for emergency positions, working on changes for purchasing cinders & other road materials, and repute prevailing wage. Park Clock- residents requesting a clock to be placed in the park. Fish Drop- Clifford Rod & Gun Club dropped fish in the park creek, Motion by Mr. Marcho to donate \$500.00 to the club 2<sup>nd</sup> by Mr. Searle. Mr. Marcho reports receiving a letter from Barhite Excavating about fuel surcharge increase. Road master contacted PennDot for guidance due to the municipality being binding by contract. Solicitor McGraw to research and give guidance. Mr. Searle reports there will be a public meeting June 24<sup>th</sup> at Susquehanna court house regarding the Susq. County Recreation Center.
