Clifford Township Supervisors Meeting May 8, 2018

Business meeting held on Tuesday, May 8, 2018. Chairman Dennis Knowlton called the meeting to order at 7:00 pm. Motion to approve the minutes by Mr. Searle, second by Mr. Knowlton. All in favor. Treasurer's report reviewed and will be put on file. List of bills reviewed. Mr. Knowlton made a motion to pay bills, except for Clifford Home & Auto, second by Mr. Searle. All in favor. Mr. Searle made a motion to pay Clifford Home & Auto, second by Mr. Knowlton. All in favor. Mr. Marcho abstained due to potential conflict of interest.

Old Business: Mr. Searle made a motion to reimburse Brennan LLC for \$150.00 for the work they did in removing three mobile homes on Rt.106 that was a part of the Mobile Home Removal Grant. Second by Mr. Knowlton. All in favor.

Supervisors agreed to have Road Master, Kurt Booths, inspect the equipment to be used by Barhite Excavating and Zembrzycki Excavating in their proposed Mowing Bids. They will make a final decision on who the winning bid will be at next month's meeting based on Mr. Booth's evaluation. \$238.12 was collected from Lapatofsky Auction LLC for the sale of miscellaneous township property from the garage that was no longer needed.

\$645.00 was collected by Robert Keating at the Clifford Annual Spring Clean Up. -\$44.00 for township tire removal and -\$300.00 for dumpster, leaving \$301.00.

Atty. McGraw is working on getting a copy of an agreement between Clinton Township and the people responsible for their wind turbines as well as a road ordinance or resolution for dust control on Tennessee Gas Road.

Mr. Searle reported on items reviewed at the annual PSATS convention such as fixed loans for septic issues (information on township website) and PSATS resolutions being proposed. He also spoke of a meeting he attended in Forest City to help with growing Clifford.

New Business: Mr. Marcho made a motion to approve a request for the Annual Clifford Fire Picnic on July 26-28, 2018. Second by Mr. Searle. All in favor.

After review, Mr. Searle made a motion to approve an application for a Mobile Home Removal Grant from Michael Massaro. Second by Mr. Knowlton. All in favor.

Township Superintendent, Larry Wilson, mentioned the 2018 Stewardship Award presented to Clifford Township and the Historical Society by Countryside Conservancy recognizing the effort and commitment to the community center, park, historical society and Hoover school. Sandy Wilmot said it was a proud moment for Clifford Township.

Resident Donna Jacoby's proposal of a 1st Annual Clifford Fall Festival was well received and she was advised to speak with Clifford's Park & Recreation committee to proceed with planning.
